It is the responsibility of the Parent to familiarize themselves with the content and themes of the event. Please do your due diligence prior to registering your child for an audition slot.

Children aged 8-17 may attend rehearsals and performances without a Parent as long as they follow the rules of CST and the rehearsal and performance venues.

Parents will be notified of their child's schedule. CST will also notify a Parent if their child is missing at a scheduled meeting. Parents are responsible for transporting their children to events on time and picking them up promptly when events are finished.

- **Cedar Street Theatre is not responsible for transportation of participants.**
- **Parents must come into the rehearsal/performance space to sign their child IN and OUT of the space. Children will only be released to Parents named on this form or those listed in the Additional Driver(s) section below.**
- **Minors who drive themselves to productions/events may sign themselves IN/OUT.**
- Children are not permitted to leave the rehearsal space for any reason without the prior approval of Parents.
- Children who miss or are late to three or more rehearsals may be dismissed from the show (at the Director’s discretion).
- Children should sit quietly when they are waiting for their turn to perform. Parents should provide them with quiet activities during down time.
- Children who do not follow directions or are generally misbehaving may be dismissed from the show (at the Director’s discretion).
- Unless serving as a Chaperone, Parents will not be allowed inside the performance venue during Tech Week. It is not uncommon for these rehearsals to run later than 10:00pm, so it is important for Parents to coordinate schoolwork for their child and to arrive on time to pick up their child.
- CST reserves the right to photograph/video all performers and crew members at any time. All media will remain the property of CST. All media may be released to social media outlets, newspapers, television, etc. Parents release all rights to their child’s image or likeness.
- CST will not be responsible for lost or stolen items during rehearsals or performances.
- CST assumes no liability for injury/harm during any part of the event (rehearsals, live performances, adjunct performances, etc.).
